1. We may change these terms from time to time without notice to you. Changes will apply to any subsequent orders received. It is your responsibility to read these terms and conditions before each purchase. By placing an order you are explicitly agreeing to these terms and conditions. 2. When you place an order, either through our website ([www.ionx.co.uk](http://www.ionx.co.uk)) or by email, we will send you an email confirming receipt of your order and containing details of your order. Your receipt of our order confirmation email can be deemed to be our acceptance of your order.
3. Goods and services are subject to availability. In the event that we are unable to supply the goods or services, we will inform you of this as soon as possible. A full refund will be given where you have already paid for the goods or services.
4. The price you pay is the price displayed on this website at the time we receive your order. However, if we discover an error in the price of the goods you have ordered we will inform you as soon as possible and give you the option of reconfirming your order at the correct price or cancelling it. If we are unable to contact you we will treat the order as cancelled. If you cancel and you have already paid for the goods, you will receive a full refund.
5. Payment can be made by any method specified by Ionx Solutions LLP. The sender is responsible for all wire fees charged by their bank.
